Addressed that the paper has worked and all residents are receiving bills. There have been no complaints not receiving. Advised council that we are down to 2 guys and working weekend, call outs and they are doing a great job. Residents are complimenting the water. Explained the schedule of the clean up weekend and a banner will be visible. Courtney met with Pastor Joe form the Mt. Sterling Church of Nazarene on the projects that need to be made. Mr. Timmons showed the t-shirts that will be worn. Courtney was able to get a free dumpster for project. Talked about an AEP program on the disposal of appliances. Council member asked questions about clean up weekend how to disposal. Council members and Mayor attended a free training given by Ohio Rural Water on April 20. It was a great and educated training. MP senior students came to Mt. Sterling for community hours and picked up trash and cleaned the village. KP fish fry is Thursday and Friday.
