19<sup>th</sup> for a Block Party with a second from Rebecca Burns, all yes.

Bob Wilson: He doesn't want a gate up, blocks his access to the back of his property. In 1986 council agreed to leave the alley the way it is. Mr. Wilson talked with the Village Administrator since the end of October. Joe took the gate down. When asked if the gate was ever locked he

said no. It is a public alley and he raised concerns about access to the alley.

Bobi Little: She said he asked the Mayor and Council President about the gate and they told her to talk to the Village Administrator. She has written permission from the Village Administrator to put up the gate. There was a lot of vandalism, trash, sexual activity and a lot of traffic back there. There has been none since the gate was put up. Bobi mows and cleans up the area. She has signed letters from two neighbors who like the gate. It is a dead end area. Mr. Wilson could

not give her a reason why he doesn't want the gate up.

The Mayor referred this matter to Joe Johnson and the Street Committee. It will be settled by

next council meeting.
