

RESOLUTION NO. 2013-10

A RESOLUTION AUTHORIZING CHARLES NEFF, MAYOR, OR HIS DESIGNEE TO FILE AN APPLICATION WITH THE STATE OF OHIO, TO PARTICIPATE IN THE CLEAN OHIO BROWNFIELDS PROGRAM; ACCEPTING THE GRANT IF FUNDED; ADMINISTER THE GRANT PROGRAM FUNDS IF RECEIVED AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio, through the Ohio Department Services Agency, provides financial assistance to local governments for the purpose of addressing local needs, and;

WHEREAS, the Village of Mount Sterling desires to participate in the Program to receive financial assistance for the Former Sterling Conveyors facility under the Clean Ohio Assistance Fund, and;

WHEREAS, the former Sterling Conveyors facility is an approximately 6.27-acre property located at 28 Clark Street in Mount Sterling, Ohio, and;

WHEREAS, the Village of Mount Sterling has the authority to apply for financial assistance and to administer the amounts received from the State of Ohio, Clean Ohio Assistance Fund, and;

WHEREAS, Clean Ohio Assistance Grant Funding could provide up to \$200,000 in assessment costs, and;

WHEREAS, the Village of Mount Sterling must direct and authorize Charles Neff, Mayor or his designee, to act in connection with the application and to provide such additional information as may be required.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MOUNT STERLING, STATE OF OHIO

SECTION I.

That the Village of Mount Sterling authorizes Charles Neff, Mayor, or his designee to act as the official representative of the Village of Mount Sterling application to participate in the State of Ohio, Ohio Department Services Agency, and provide all information and documentation required in said Application for State of Ohio Clean Ohio Assistance Fund submission.

SECTION II.

That Village of Mount Sterling hereby approves filing an application for financial assistance under the Clean Ohio Assistance Fund.

SECTION III.

That the Village of Mount Sterling hereby understands and agrees that participation in the Program will require compliance with program guidelines and assurances.

SECTION IV.

This resolution is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health and safety of the inhabitants of the Village of Mount Sterling. The emergency existing is the continued sound fiscal management of the Village and to provide the citizens of Mount Sterling a safe environment to live and raise their children by cleaning up environmental polluted areas of the Village of Mount Sterling. This resolution shall be in full force and effective upon the passage and signing by the Mayor.

SECTION V.

That the Clerk of Council, pursuant to O.R.C. 731.23, shall cause to be published in a manner required by law, this resolution.
