**RESOLUTION TO CONTRACT WITH THE MADISON COUNTY SHERIFF'S DEPARTMENT FOR LAW ENFORCEMENT SERVICES AND DECLARE AN EMERGENCY**

**WHEREAS**, the current service agreement with the Madison County Sheriff's Department is up on February 28, 2016, and;

**WHEREAS**, the Finance Committee recommends to Village Council that a new service agreement be entered into between the Village of Mount Sterling and the Madison County Sheriff's Department, and;

**WHEREAS**, the Council of the Village of Mount Sterling believes that it is appropriate to contract with the Madison County Sheriff's Department for another four (4) years.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MOUNT STERLING, STATE OF OHIO**

**SECTION I.**

The Council of the Village of Mount Sterling authorizes Charles Neff, Mayor, or his designee to enter into the Contract for Services, attached hereto, pursuant to the terms and conditions contained herein.

**SECTION II.**

That the provisions of this resolution shall be in full force and effect from and immediately after the passage of this resolution and its approval by the Mayor and majority of Council.

**SECTION III.**

That the Clerk of Council, pursuant to O.R.C §731.23, shall cause to be published in a manner required by law this resolution.

**SECTION IV.**

This resolution is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health and safety of the inhabitants of the Village of Mount Sterling. The emergency existing is the continued sound fiscal management of the Village's financial affairs, and policing of the roadway, streets, alleys and building within the Village. This resolution shall be in full force and effective upon the passage and signing by the Mayor.
